The criminal history, if any, and DMV record of all applicants and employees may also be reviewed before and periodically during employment. All offers of employment can be conditioned upon the applicant's consent to, and passing, a job-related pre-employment medical examination which may include a drug and alcohol screening. Further, if hired, all incumbent employees may, at any time, be required to submit to additional job-related drug and alcohol screening, if applicable to the position.
